Your federation has asked me to carry out a review of your federation's Income Statement and Financial Report as the liquidity situation for the year 2015.

I have carried out the work during the week August $17^{th} - 22^{nd}$ 2015. All necessary documents were available to me, furthermore you and your staff members have been available for all relevant issues and the answering of questions during my exercise.

Please note that I did not carry out a full audit. I did review all relevant data and documents for the reasonableness. Whenever I considered it necessary, I carried out some detailed audit steps.

The federation is maintaining its accounting system on a straight cash basis. In the year 2015, the federation employed ten (10) full time staff members. This is the same number as the previous year, but an increase in the IFMA Staff Salary expense indicates that the federation has seen good performance form its staff members and is actively working towards building a loyal and committed core of staff. The Income Statement shows clearly the Federation's on-going commitment to its international expansion. These efforts are reflected in the following expense categories:

International Games Support \$85,290.00

Event expenses \$142,600.00

With a profit of \$134,520.00 in the division Broadcasting/TV Production, the Federation shows a successful maintenance of a project which serves to boost exposure and popularity of the sport internationally.

An increase in expenses dedicated to Youth Development reflect the organisation's investment in a grass-roots development philosophy which is indicative of the priority given to the future generations of the sport.

The federation has maintained its spending on charitable projects which include three initiatives in particular namely "Muaythai Against Drugs", "Sport Is your Gang" and "End Violence Against Women (EVAW) in cooperation with UN Women". This shows the federation's ongoing commitment to maintaining these ongoing projects.
